## Enrolment Terms and Conditions

It is the responsibility of the responsible person to ensure the account remains financial.

All customers who have ongoing bookings with the DKHAC Aquatic Centre are required to have a current direct debit agreement in place to secure their booking for upcoming terms.

Customers choosing to not have a current direct debit agreement will not have ongoing bookings and will have bookings automatically cancelled at the end of each term.

All new enrolments will produce a pro-rata amount in our system to cover any period before your first direct debit payment is processed. This means you will have a one-week OR two-week payment (depending on the enrolment date) due before your first lesson. This pro-rata payment can be made at the customer service desk before you enter for your first lesson.

All children must be supervised by a responsible person aged over 16 while at the Doone Kennedy Hobart Aquatic Centre. All children aged under 6 years old must be accompanied in the water by the responsible person aged over 16 when not attending a class.

To cancel an enrolment a Cancellation Form must be completed, 3 days' notice prior to the direct debiting date is required.

Students must wear appropriate swim wear but rash tops, goggles or swim caps are optional.
